STEP 2 – STUDENT RESPONSIBILITY (please initial each):

- _____ I understand that the Yellow Ribbon program is available on a limited funding basis at FCC to students under the 100% eligibility tier of Chapter 33, Post 9/11 GI Bill and who are being charged the out-of-state tuition rate. Funding will be awarded on a first-come, first-served basis.
- _____ I understand that, if I am granted Yellow Ribbon, I will receive no more than \$2000 total assistance (a combination of Yellow Ribbon federal funds and FCC matching funds) in any one academic year (Fall through Summer semesters) and no more than \$1000 of that amount in any one semester.
- _____ I understand that any change in my eligibility for Chapter 33, Post 9/11 GI Bill will result in a change to my yellow ribbon eligibility. This means that a reduction to or loss of Chapter 33, Post 9/11 GI Bill funds in any semester and for any reason will also result in a reduction to or loss of Yellow Ribbon in that same semester. This may cause me to owe a balance to FCC.
- _____ If I live within the state of Maryland, I understand that I will need to establish residency for the next semester and will only be eligible for Yellow Ribbon in my first semester at FCC.
- _____ I understand that if I am eligible for the in-county or in-state tuition rate due to employment in the state of Maryland, I will utilize that benefit in lieu of applying for Yellow Ribbon.
- _____ I understand that I must reapply for Yellow Ribbon each semester, if I remain eligible, and that receipt of or continued receipt of the benefit is not guaranteed.
- _____ I understand that my Yellow Ribbon Application will not be accepted any earlier than the first day of early registration (generally April and November) for each upcoming semester. If I turn the application in before the first day of early registration, it will be returned to me as unacceptable.

I have read the above information and I understand my responsibilities in claiming VA education benefits at FCC. I also understand that FCC is responsible for communicating accurate enrollment data to the VA and any failure on my part to comply with the above conditions will jeopardize my continued receipt of VA education benefits at FCC.
