This Letter of Recognition is designed to provide focused study in, and a unique credential for, various specialized areas of study within the field of Emergency Management. Each credential is obtained through the following process:

- Complete the required "FEMA" credits listed for the EMGT course you select, via completion
  of the appropriate FEMA Independent Study coursework (listed parenthetically alongside
  "FEMA" designation) and conversion to FCC credit via EMstudy.com.
- Enroll for your chosen EMGT course (EMGT 165 189, see Catalog) here at FCC. These are 5-week, instructor-led, online courses offered in the Spring, Summer, and Fall semesters, allowing more thorough study, engagement with, and assessment of the material and specialty area than what FEMA's Independent Study courses provide. (NOTE: EMGT courses are requirements; completion of the appropriate 6-7 FEMA credits or their component Independent Study (IS) material will not by itself result in a credential of any kind.)
- Complete the EMGT course and apply for graduation with the Letter of Recognition for Emergency Management – Specialized Studies!
