# **KNOW YOUR IX**

## Prevention of sexual misconduct on campus at Frederick Community College.

#### WHAT IS TITLE IX?

- 1. Title IX (Sexual Misconduct) is a civil right that prohibits sex discrimination in education.
- 2. Title IX applies to all students, faculty, and staff regardless of gender identity.
- 3. All schools, including Frederick Community College (FCC), who receive federal funding are subject to Title IX and so you are protected by Title IX here at FCC.
- Title IX protects students from gender/ sex discrimination including harassment and assault. It also guarantees students accommodations if you are pregnant or nursing.
- 5. Students have the right to report incidents of sexual violence to campus officials.
- 6. Schools must have an established procedure for handling complaints of sexual harassment, discrimination, and violence.
- 7. Schools should ensure that no person has to share campus (such as dorms, classes, and workplaces) with their abuser.
- 8. Schools may not retaliate against someone filing a complaint and must keep complainants safe from retaliation.
- 9. Schools must be proactive in ensuring that your campus is free from sex discrimination.
