Appeal for Financial Aid Suspension, Maximum Time Frame and Unusual Enrollment History

<u>Financial Aid Suspension</u>: Your grade point average (GPA) and/or completion rate do not meet the required standards for your level of attempted courses. You have the right to appeal your suspension by doing the following:

- 1. Complete this form and attach a typed or legibly written explanation of the following:
 - a. What extenuating circumstances prevented you from being successful in your academic coursework and from meeting the required financial aid grade point average/completion rate at FCC? You need to address all semesters in which you had unsuccessful (F, W, AU, U, I) grades. Also address D grades for developmental coursework or for college level courses if your GPA is below the standards.
 - b. Are these circumstances resolved? What steps have you taken to ensure your future success?
 - c. What are your career/educational goals?
- 2. Attach any documentation that can support your case for extenuating circumstances and plan for success. If you have no supporting documentation, contact the financial aid office for assistance. Failure to submit documentation will likely result in your appeal being denied.
- 3. Submit all of the above to the Financial Aid Office by the deadline on your suspension email. <u>Incomplete appeal</u> packets will be denied.

Maximum Time Frame: You have attempted more credits than financial aid eligibility allows or cannot complete in the maximum timeframe for your program of study. You have the right to appeal for an extension of your eligibility by doing the following:

- 1. Complete this form and attach a typed or legibly written explanation of the following.
 - a. What program are you pursuing at FCC and why were you unable to complete it within 150% of the time (credits) needed to finish the requirements? For example, AS Nursing requires 70 credits. Maximum time frame occurs when attempted/transferred in credits exceed 105 (70 x 1.5). Address the reasons for all unsuccessful grades (F, W, AU, U, I), repeated grades, and any program changes. Also address D grades for developmental coursework. If you have already completed a degree at FCC and are pursuing another program, explain why you need this additional degree/certificate.
 - b. If your reasons were extenuating, are they resolved? What steps have you taken to ensure that you will be successful in completing the requirements if the appeal is granted?
- 2. Attach any documentation that can support your case for extenuating circumstances and plan for success. If you are unable to provide documentation, explain why in your typed statement.
- 3. Submit all of the above to the Financial Aid Office by the deadline on your suspension email. <u>Incomplete appeal</u> packets will be denied.

<u>Unusual Enrollment History</u>: The Financial Aid Committee has reviewed your Enrollment History Verification Form and has determined that you cannot be granted financial aid eligibility. You have the right to appeal by doing the following:

- 1. Complete 6 credits at FCC at your own expense (this is a requirement set by the Department of Education).
- 2. After step 1 is documented on your FCC transcript, complete this form and attach a typed or legibly written explanation of why you enrolled in multiple schools and received a financial aid credit without successfully completing coursework. You should address all schools attended and attach any documentation that can support your case.
- 3. Submit all of the above to the Financial Aid Office. Incomplete appeal packets will not be reviewed.
