

# Pre-Health Professions: Surgical Technology A.A.S.

## Application Dates

Fall Start: Early Admission deadline is April 1<sup>st</sup>; Best Consideration is June 1<sup>st</sup>

Spring Start: Early Admission deadline is October 15<sup>th</sup>; Best Consideration is December 1<sup>st</sup>

1. **Apply to the College:** Apply to Frederick Community College and declare Pre-Health Professions Surgical Technology AAS as your major.
2. **Submit Official Transcripts:** Send official college/university and high school transcripts, SAT & ACT scores as well as any CLEP, IB or AP scores to the Registration and Records Office.

*Note that official college/university transcripts should be sent upon application to FCC, and must be received by application date for Surgical Technology program*

3. **Apply for Financial Aid:** Apply for Financial Assistance – Submit the FAFSA and apply for scholarships.
4. **Complete Placement Tests:** Complete FCC placement tests as needed – consult with Admissions or Advising.
5. **Complete Pre-Admission Courses:** The following requirements must be completed with minimum grades of C prior to application to the Surgical Technology program

ENGL101 (EN101) – English Composition  
MATH – MATH120 Statistics or higher  
COMM (CMSP) - A General Education  
Communications Elective

PSYC101 (PS101) – General Psychology  
or SOCY101 (SO101) – Introduction to Sociology  
[Science prerequisite: BSCI55, BSCI150, or CHEM101]  
BSCI201 (BI103) - Anatomy & Physiology I \*\*

The following requirements can be in progress at the time of application and must be completed with minimum grades of C prior to starting the Surgical Technology program (if admitted):

BSCI202 (BI104) - Anatomy & Physiology II\*\*  
MEDA109\* (MDA109\*)  
or MEDA108 (MDA108) – Medical  
Terminology\*

1- to 3-credit PHED, HLTH or NUTR elective  
Up to 6-credits of electives\* (to total 28 credits of  
general education courses and free electives)

6. **Complete Job Shadowing:** Complete job shadowing with positive recommendation and submit verification form and 1-2 page reflection paper by first consideration date, or upon application for admission to the Surgical Technology Program if after the first consideration date. First consideration dates are April 15<sup>th</sup> for the Fall cohort and October 15<sup>th</sup> for the Spring cohort.

Apply to job shadow through Frederick Health Hospital [here](#). Jeanne Queen, RN, will be your mentor/preceptor at Frederick Health Hospital (needed for job shadow application). Job shadow experiences do NOT need to be completed at FHH. However, you will need to make your own arrangements for experiences outside of FHH.

7. **Submit Application to the Surgical Technology Program:** Submit the online application for Surgical Technology Program once you have finished or are in progress with your final pre-admission courses as outlined above (#5).
