ARTICULATION AGREEMENT BETWEEN

FREDERICK COMMUNITY COLLEGE, FREDERICK, MARYLAND AND CHARTER OAK STATE COLLEGE, NEW BRITAIN, CONNECTICUT

This Articulation Agreement includes a course-by-course evaluation of the Frederick Community College's offerings based on the 2005-06 Catalog. Charter Oak State College agrees to accept toward a Bachelor's degree all courses designated as being acceptable credits in the Agreement, providing the courses meet the degree requirements the student is seeking.

This Agreement indicates how each course will transfer to Charter Oak State College, based on the policies in effect at the time the Articulation Agreement was developed. As academic policies at Charter Oak State College and at the Frederick Community College change, the Articulation Agreement will be amended to reflect the changes. Policies in effect at the time the student matriculates at Charter Oak State College will govern the student. Charter Oak State College will maintain all transfer evaluations conducted of Frederick Community College's courses during the life of this Agreement.

The Articulation Agreement will be updated periodically, normally every two years, to reflect changes in course offerings and polices of both Charter Oak State College and Frederick Community College.

- 4.) One course or exam may satisfy more than one requirement.
- 5.) Up to 90 credits may be transferred in from a 2-year institution.
- 6.) Credits earned through standardized exams are counted as coming from beyond a 2-year institution.
- 7.) Concentrations must include a minimum of 36 credits. At least 15 of those credits must be at the upper division. The PSA courses fulfill the concentration requirements for number and level of credits.
- 8.) Although COSC has <u>no residency requirement</u> students are required to take COSC courses in the PSA concentration (except 9 course credits).
