## Checklist for Students Using Montgomery GI Bill® – Selected Reserve (Chapter 1606)

## *Required steps for students using the Montgomery GI Bill – Selected Reserve:*

\*Please submit any documents containing personally identifiable information using the <u>Secure Document</u> <u>Submission form</u> or you may bring documents with you to an in-person intake appointment.

- **Submit the following documents to Veteran and Military Services (VMS):** 
  - a. Notice of Basic Eligibility (NOBE; DD Form 2384-1) from your unit
  - b. VA Certificate of Eligibility (COE) or current statement of benefits
    - i. If you are using your benefit for the first time and have not yet applied for it, fill out <u>VA Form 22-1990</u> (Application for VA Education Benefits). You can "start your application without signing in." Submit a copy of your COE to Veteran and Military Services once you receive it. \*\*\*Note that you must have your NOBE prior to applying for your benefit.
- □ Fill out FCC's free online application for admission <u>here</u>.
- □ Submit official transcripts and/or score reports to FCC's Registrar's Office to be evaluated for credit and <u>determine if you are exempt</u> from the reading, writing, and/or math placement tests. For information about how to submit them go <u>here.</u>
  - c. Submit official transcripts from any colleges and/or universities where you earned credit.
  - d. Submit SAT, ACT, or AP score reports if they exempt you from taking the placement tests or yield credit (AP)
  - e. Submit official military transcripts for evaluation
    - i. Joint Services Transcript (JST) (All branches EXCEPT Air Force): create an account and request to have your official JST sent to FCC electronically <u>here</u>
    - ii. Community College of the Air Force (CCAF) Transcript: see how to request an official copy <u>here</u>
- Take the placement tests if you are not <u>exempt</u>. For information about how to take the tests go <u>here</u>.
  For resources that will help you prepare to take each test go <u>here</u>.
- **Submit unofficial copies of college/university transcripts to VMS for advising purposes if possible**
- Optional: Apply for federal student aid to see if you are eligible to receive a need-based Pell Grant.

- □ **Schedule an intake appointment** <u>here</u>. Please submit as much of the required documentation as possible prior to your appointment or bring it with you to an in-person appointment. **We will ask for**

your SSN, which is required for VA enrollment certification, at your appointment. For security *purposes, please do not email it to us!* \*\*\*We do NOT need to have all of your documentation on file before you register for classes.
